EDUCATION REQUIREMENT INFORMATION

The education keynote of "Into the Woods" is a celebration of the natural beauty encountered while walking in the woods, and an effort to motivate visitors to bring the beauty of the woods and all of its environmental benefits to their neighborhoods by planting more trees demonstrated in the two Division V Education Exhibits: Re-Leaf Grosse Pointe and Right Tree, Right Place.

GIVE A HOOT! GCA RULES

- 1. Please carefully read and follow GCA Flower Show Rules, General Information, and Division Guidelines. All rules as stated in *The Garden Club of America Flower Show and Judging Guide (FS & JG)*, July 2022 edition, shall apply.
- 2. All plant material must be correctly identified with the botanical and common names, if possible. Accepted references for nomenclature are:
 - a. Missouri Botanical Garden Plant Finder at https://www.missouribotanicalgarden.org/plantfinder/plantfindersearch.aspx
 - b. Royal Horticultural Society Find a Plant at https://www.rhs.org.uk/plants/search-Form
- 3. The Garden Club of America expects all exhibitors to be aware of the need to promote conservation of endangered and threatened plants. Plants collected in the wild and listed by the Michigan Natural Heritage Program may not be exhibited in any flower show sponsored by a GCA club. Cultivated plant material listed by Michigan's Natural Heritage Program may be exhibited if accompanied by a typed card stating that it has not been collected from the wild or that it was collected out-of-state and giving information concerning its cultural requirements and methods of propagation. Natural Heritage Program lists of endangered plant material will be available before and during the show from the division chairmen and are available online at https://plants.usda.gov/home/raritySearch
- 4. Plant material showing evidence of insects or disease must be removed immediately from the exhibition area. This rule will be enforced at any time during the show, whenever the problem is identified.
- 5. All entries in the Floral Design and Horticulture Divisions must include fresh and/or dried plant material. Fresh plant material must be in water or conditioned in such a way as to remain in pristine form while on exhibition. An entry not maintained in show condition may have its award removed. Entries in Photography are required to include plant material.
- 6. Locally invasive plants, diseased plant material, artificial plant material, live animals (including fish), taxidermy, natural birds' nests, feathers of any kind, and

protected sea life, including coral, are not permitted. No animal parts (from live or deceased animals) may be used. This includes, but is not limited to, hooves, horns, fur (with the exception of wool/yarn), hair, fins, seashells, and other shells (turtle, egg, etc.). The Photography Division is exempt from this rule, but all photographs must show respect for the natural world and be taken in an ethically responsible way. Information is available online at

You Can See the Forest Through the Trees! GENERAL INFORMATION

- 1. Until all classes are filled, any interested person may enter an exhibit in any class except Division II, Class 49, which is open to Garden Club of Michigan members only.
- 2. It is extremely important that all designs are the original work of the designer(s). While the use of various techniques and components and the artistic concept to the design must be original. Artistic integrity is of utmost importance.
- 3. Pre-registration is required for Division I, Division II, Class 49 and Division III. Registration forms are provided at the back of the schedule. Registration will be staggered, please see page 5 for details. Classes will be filled in the order registration forms are received according to the postmark/email date and time.
- 4. Only one entry per exhibitor is encouraged in floral design, photography, and education classes. Exceptions may be made if needed to fill a class.
- 5. Entering a show constitutes permission to use images of the submitted content in all GCA channels of communication.
- 6. While The Garden Club of America, The Garden Club of Michigan, and The Grosse Pointe Club will exercise due caution in safeguarding exhibits, responsibility for damage, loss, or personal injury cannot be assumed.
- 7. Any clarification or change in the rules, as originally stated in the schedule, shall be communicated promptly in writing by the division chairman to all exhibitors in the class and, at the show, to the judges and the passing committee.
- 8. An entry card must accompany each entry. Entry cards will be available at the show and upon request from the registration or division chairmen in advance of the show. Information required on the entry card must be completed in black waterproof medium.
- 9. *The passing committee must pass each entry before an exhibitor may leave the show area.* The passing committee reserves the right to refuse any entry that does

not conform to the rules of the schedule. The exhibitor has the option of correcting the entry if time permits. If not corrected, the entry cannot be judged but may remain in place, marked "For Exhibit Only" with a brief, constructively worded statement explaining why it was not judged. The judges may not disqualify any entry passed by the passing committee unless evidence of insect infestation or disease is identified.

- 10. Once an entry is passed, the exhibitor(s) must immediately leave the show floor. The only exception will be flower show committee members who have entered and been passed according to the timetable. A passed entry may not be touched again by the exhibitor(s) until after judging and then only to carry out necessary maintenance.
- 11. Only participating judges and clerks will be allowed on the show floor during judging. Flower Show Chairmen and division chairmen should remain nearby but off the show floor until needed.
- 12. All containers and accessories must be inconspicuously labeled with the exhibitor's name.
- 13. A novice is an individual exhibitor who has not won a first-place ribbon or a GCA Special Award in the division entered at a GCA Flower Show, GCA Major Flower Show, or Sanctioned Non-GCA Major Flower Show. An exhibitor winning a first-place ribbon in a GCA Flower Show is still considered a novice in a GCA Major Flower Show, a Sanctioned Non-GCA Major Flower Show, or in another division of any flower show. In addition, an exhibitor who has won a first-place ribbon or Special Award in a GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show is no longer a novice in any level of GCA Flower Shows in the division won. Only individual novice exhibitors are eligible to receive the GCA Novice Awards or the Sandra Baylor Novice Floral Design Award. A novice exhibitor will be identified on the entry card following the initial judging.
- 14. A Statement of Intent, either optional or required, must be submitted at the time of passing. The statement must be no more than 25 words typed or printed in black waterproof medium on a 4" x 6" or 5" x 8" white unlined card.
- 15. All Judges' decisions are final.
- 16. All exhibits must remain in place and in show condition until fifteen minutes following the closing time of the show.

DIVISION I A Walk in the Woods Floral Design Guidelines

- 1. Please carefully read and follow the GCA Rules, General Information, and Timetable for Exhibitors.
- 2. Advance registration is required by August 1, 2023.
- 3. An exhibitor may submit only one entry per class, but may enter more than one class. The exhibitor(s) under whose name(s) the entry has been registered must create and complete the design. All participants must be listed on the entry card. Only listed exhibitors and show personnel may be on the show floor at the time of entry.
- 4. No more than two exhibitors may execute a design unless otherwise stated in the schedule.
- 5. If forced to withdraw, an exhibitor must notify the registration chairman and class consultant and find a substitute unless there is a waiting list for the class.
- 6. It is extremely important that all designs are the original work of the designer(s). While the use of various techniques and components in the design may be inspired by other designs, the application of the techniques and components and the artistic concept of the design must be original. Artistic integrity is of utmost importance.
- 7. Designs may be executed off-site and brought to the show completed.
- 8. All entries must include fresh and/or dried plant material. Fresh plant material must be in water or conditioned in such a way as to remain in pristine form while on exhibition. Rooted plant material is allowed, provided no soil is attached. An entry not maintained in show condition may have its award removed.
- 9. Mechanics should not be visible unless they are an integral part of the design.
- 10. Anything not prohibited in the GCA Rules, Floral Design Division Guidelines, or individual class descriptions is permitted.
- 11. Although permitted, the use of cut fruits and vegetables is discouraged and should be undertaken only with proper treatment to prevent spoilage and insect contamination.
- 12. Judging will be based on the principles of design: balance, contrast, dominance, proportion, rhythm, and scale, and the elements of design: light, space, line, form, color, texture, pattern, and size. Creativity is important, as are distinction, conformance to and interpretation of the class, and schedule.
- 13. Accessories are permitted in all classes.

- 14. All pedestals and platforms are painted black. They may not be moved. *Tops of pedestals may not be enlarged or draped*.
- 15. Questions regarding class requirements may be directed to the class consultant and/or division chairman.

A mannequin clothed in at least 51% plant material, to be staged on an 18" high black base, 30" wide by 30" deep. Height not to exceed 80" from the floor. Design must be contained within the platform's boundaries. Viewed from all sides.

Class 2 **Changing Seasons**

A design incorporating plant material of just two colors, including shades and tints of the hue, staged on a black pedestal 44" high x 12" square. Not to exceed more than 18" from the center of the pedestal in width and depth, and no higher than 26" from the top of the pedestal. Seasons to be chosen at the time of registration: Winter/Spring, Spring/Summer, Summer/Autumn, Autumn/Winter. No duplications. Viewed from all sides.

Class 3 By the Light of the Moon

A diminutive design not more than five inches in height, width, and depth staged in a 9 $\frac{1}{2}$ " inch cubed niche that is black on the outside and cream on the inside with a circular opening on the front, 6" in diameter, $\frac{1}{2}$ " from the base. Any lining used must be removable without damage to the surface of the niche. Placed on a 52" high x 14" square lucite pedestal. Niche and stick on light will be provided to the exhibitor at the time of registration. Viewed from the front.

A design staged on a black base, 18" high, 30" wide by 30" deep. Design must stay within the platform boundaries. Height not to exceed 76" from the floor. Viewed from all sides.

Class 8 Bent and Twisted

A design using a 30" in diameter, copper-colored, double metal hoop with holes every inch, staged on a 44" high by 12" square black pedestal. The arrangement should not extend more than 19" from the center of the pedestal. Viewed from four sides. Must be finished in the round. The hoop will be provided to the exhibitor at the time of registration.

DIVISION II Into the Meadow Horticulture Guidelines

- 1. Please carefully read and follow the GCA Rules, General Information, and Timetable for Exhibitors.
- 2. Advance registration for the challenge class is required by Monday, May 1, 2023.
- 3. An exhibitor may submit 3 entries per class, provided each is a different species or cultivar.
- 4. Entries must have been owned and grown by the exhibitor for a minimum of three months unless otherwise stated in the schedule.
- 5. Entries eligible for the **Catherine Beattie Medal** and/or the **Clarissa Willemsen Horticulture Propagation Award** must have been in the possession of the exhibitor for at least six months and will be identified on the entry card.
- 6. All rooted entries propagated by the exhibitor must be identified with details of the method and relevant date(s) on an accompanying propagation card to be eligible for the **Clarissa Willemsen Horticulture Propagation Award**.
- 7. Bases, mats, stands, and saucers are not allowed. Saucers will be provided by the committee. Unobtrusive staking and tying are permitted.
- 8. **Subdivision is preferable in the schedule rather than on the floor.** Classes may be subdivided, and entries moved and/or reclassified at the discretion of the show committee and/or the judges.
- 9. Containers are measured at the diameter or the diagonal of the widest point on the inside of the rim at the soil line.
- 10. One key card (diagram or plant list) is required when multiple species or cultivars are exhibited in the same container and/or propagation information is applicable. Key card must be a 4" x 6" white, unlined card completed in black, waterproof medium. A 4" x 6" photograph with identifying numbers may be used.
- 11. Container-grown plants must be exhibited in containers that are clean, unobtrusive, and compatible with the exhibit. Terracotta clay pots are preferred. Other options include stone-like (Hypertufa), wire baskets, slatted orchid baskets, and plants mounted on driftwood. Disguised double potting and top dressing are permitted; top dressing must not float when watered.
- 12. Cut specimens should be brought to the flower show by the exhibitor already in green glass bottles and wedged, if necessary, with clear plastic wrap (preferably compostable), natural cork, or small bubble wrap (repurposed).

- 13. A dot with the entry number on it should be affixed to the container at the entry table to ensure an entry card, separated from the exhibit container during staging, can be returned to the proper entry before judging.
- 14. The committee will water the exhibits if instructed to do so in writing. Notify the division chairman at the time of entry with written instructions for watering.
- 15. Lists of the scale of pointe by which the classes are to be judged: Please refer to the *FS & JG Book 4: Pocket Guide @the Show, July 2022 edition.*

DIVISION III Photosynthesis Photography Guidelines

- 1. Please carefully read and follow the GCA Rules, General Information, and Timetable for Exhibitors.
- 2. An exhibitor may submit only one entry per class, but is encouraged to list a second choice in case there are openings.
- 3. Advance registration is required by August 1, 2023. Exhibitors will be notified of acceptance at the time of registration.
- 4. If forced to withdraw, an exhibitor must notify the division chairman and class consultant and find a substitute unless there is a waiting list for the class.
- 5. A photograph previously entered in any GCA, GCA Major, Sanctioned Non-GCA Major Flower Show, or a GCA *Focus* online contest may not be entered again even with slight alterations and/or reprinting. The same photograph may only be entered in one show at a time. If a photo is not advanced as a finalist in Juried Judging, it may be entered into a second Juried FS, a GCA FS, a GCA Major FS, or a Club Show. Editing is allowed.
- 6. A photograph that has been entered into a Club show, may be entered again into a GCA show, Zone Show, GCA Major show or a Sanctioned Non-GCA show, unless that photograph was submitted for publication in the *Focus* photography gallery or a printed issue of *Focus*.
- 7. Each photograph must be the work of the exhibitor under whose name it is registered. In manipulated photographs, any added imagery must be the work of the exhibitor. Non-representational commercial overlays and textures are allowed. Matting, mounting and printing may be done professionally. All photographs must be 2-dimensional and printed on paper unless otherwise specified. All post-production must be done before the photograph is printed.
- 8. Editing at any stage must be the work of the exhibitor. This includes enhancement for color or clarity, removal of a part of the image, combining images, or distorting the original subject.
- 9. Photography entries are limited to subjects consistent with The Garden Club of America's interests such as horticulture, floral design, gardens/landscapes, conservation, the environment, historic preservation, civic improvement, and the natural world. Plant material is required in photographs.
- 10. Photographs must be mounted on black foam core and may not be over-matted. Overall dimension of entry must be a minimum of 36 inches and not exceed 60

inches in total perimeter measurement. The surface finish is the choice of the exhibitor. Glass and framing are not permitted.

- 11. Each photograph must have the entry form affixed to the back of the mounting with the exhibitor's name, garden club, zone, email, address, phone number, and class entered. The top of the photograph must be indicated. LINK TO ENTRY CARDS Print entry cards on card stock in black ink. Three entry cards will print on 8 ½ x 11 inch paper. Use one to affix to the back of the photograph. Complete the 2nd entry card as well and mail it along with the Photography/Entry. The division chairman will use the 2nd entry card to stage each photograph.
- 12. A title or statement of intent, not to exceed 25 words, and identification of the dominant plant material is required on the entry form.
- 13. Photographs will be hung against a black background.
- 14. Printed photographs must be received no later than Friday, August 25, 2023. Send photographs on foam core to Lindsey Buhl, 44 Lee Gate Lane, Grosse Pointe Farms, 48236. You will receive an email confirmation once your photograph is received. For information, contact Lindsey Buhl at lindsey@buhl.com.
- 15. Photographs will be passed by the photography committee to verify that class specifications have been met. If a photograph is not passed, the exhibitor will be notified and allowed, if time permits, to send a replacement photograph.
- 16. The photography committee may reclassify an entry, but only with the exhibitor's permission. The photography committee and/or the judges may subdivide a class.
- 17. Only appropriate images of a child or children should be submitted to, passed, and exhibited in the Photography Division and published in *Focus*. Featuring identifiable people (other than in street scenes) in photographs is discouraged as GCA requires a release.
- 18. If a photograph is to be returned, the exhibitor must provide a self-addressed label, envelope or mailing box, postage (see below) and packing material. Any award received will be noted on the back of the mount before it is returned. If a photograph will not be returned, to receive the comment card and any award won, include a self-addressed and stamped envelope

POSTAGE: Please include a \$12 check (payable to the Garden Club of Michigan) to cover return postage and handling of photography, comment card, and award, if any. If the return envelope and postage check are not included, it will be assumed that the image, award, and comment card will not be returned.

Recommended:

Use two 15" X 19" bubble wrap envelopes or a reusable mailing box. (Smaller envelopes are too tight.) Wrap the mounted image between two suitable pieces of foam core (this is very light) or non-bendable cardboard, which will be reused for return. Place wrapped image inside reusable mailing box, or inside mailing envelope with a folded self-addressed return envelope.

GCA FLOWER SHOW AWARDS

GCA Flower Show Awards described below have been applied for and will be presented if merited.

Division I, Floral Design

Best in Show Floral Design is selected from first place winners in the division.

The **Dorothy Vietor Munger Award** may be awarded to members of The Garden Club of America clubs in competitive Floral Design classes at a GCA Flower Show. It is offered in recognition of creative work of outstanding beauty using predominantly fresh plant material. The design must have placed first, second, or third. Challenge class entries are not eligible. The award is not a substitute for Best in Show and will be given at the discretion of the judges.

The **Harriet DeWaele Puckett Creativity Award** may be awarded to members of GCA clubs or non-members in recognition of a uniquely skillful and creative response to an imaginative schedule in Floral Design. It will be given for an innovative and interpretive entry, which, although it abides by the principles of good design, goes beyond traditional period arrangement to whatever art form the exhibitor(s) chooses. The design must have placed first, second, or third in the Floral Design Division of a GCA Flower Show. An entry in any challenge class is not eligible to receive this award. The award is not a substitute for Best in Show and will be given at the discretion of the judges.

The **Sandra Baylor Novice Floral Design Award** may be given at a GCA Flower Show to an exhibitor who is a member of a GCA club and who has never won first place, or a GCA Special Award in the Floral Design Division of a GCA Flower Show, GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show. It shall be awarded to an individual novice exhibitor for a unique and skillful response to the schedule. Novice entries placing first, second, or third in any competitive class, including challenge classes, are eligible for this award.

<u>Division II, Horticulture</u>

Best in Show Horticulture is selected from first place winners in the division.

The **Catherine Beattie Medal** may be awarded for a horticulture entry distinguished by its vibrancy, prime condition, and perfection of grooming. The exhibitor must have owned and grown the exhibit for at least six months. The medal may be awarded for a single plant, collection of plants, container garden, or cut specimen, but only if there is an exhibit worthy of the honor. It may be awarded to members of GCA clubs only; individual, joint, and club entries are eligible. The award should not be considered as a substitute for Best in Show. The medal may not be awarded to the same exhibit more than once; however, offspring of a Beattie winner are eligible to receive the award.

The **GCA Novice Award in Horticulture** may be awarded for an outstanding exhibit to a member of a GCA club who has never won first place or a GCA Special Award in the Horticulture Division in a GCA Flower Show, GCA Major Flower Show or Sanctioned non-GCA Major Flower Show. Novice entries placing first, second, or third are eligible for this award.

The **Clarissa Willemsen Horticulture Propagation Award** may be awarded for a horticulture entry distinguished by its prime condition, flawless grooming, and difficulty of propagation. The entry must have been propagated and grown by the exhibitor for at least six months. This award may be given to a single rooted plant or a collection of rooted plants. The dates and method of propagation must be recorded on an accompanying propagation card. The entry must have placed first, second, or third at a GCA Flower Show. The award may not be given to the same exhibit more than once.

The **Rosie Jones Horticulture Award** may be presented to a horticulture entry of exceptional visual appeal that reflects the spirit of growing with joy and enthusiasm and inspires others to propagate, grow, show and share horticulture. An exhibit that has been propagated by the exhibitor will be given special consideration, but propagation is not a requirement. Perfection, while always desirable, is not a primary criterion. This award celebrates the ineffable joy inherent in the beauty and pursuit of horticulture.

Division III, Photography

Best in Show Photography is selected from first place winners in the division.

The **GCA Novice Award in Photography** may be awarded for an outstanding exhibit to a member of a GCA club who has never won first place or a GCA Special Award in the Photography Division in a GCA Flower Show, GCA Major Flower Show or Sanctioned non-GCA Major Flower Show. Novice entries placing first, second, or third are eligible for this award.

The **Photography Creativity Award** may be awarded at a GCA Flower Show to a member of a GCA club in recognition of creative and technical excellence in response to the theme of the schedule. The entry must have placed first, second, or third.

Division V, Education

<u>Large Exhibit - Education</u>

The **Ann Lyon Crammond Award** may be presented at a GCA Flower Show to an outstanding educational exhibit, which best educates the public about gardens. Any educational exhibit, which increases the appreciation of any aspect of plants, gardens, or landscape design, may be considered for this award. The award may be given to GCA club members, member clubs, non-members or other organizations.

Large Exhibit - Conservation

The **Marion Thompson Fuller Brown Conservation Award** may be presented for an outstanding conservation exhibit at a GCA Flower Show. The award recognizes an exhibit of exceptional educational and visual merit, which increases knowledge and awareness of the environment. The exhibit should emphasize environmental concerns and may demonstrate conservation practices. Plant material may or may not be used and, when appropriate, must be clearly identified. Protected material may be included if such materials are identified as protected and not collected in the wild. The award may be

given to The Garden Club of America clubs, club members, non-members or other organizations.

<u>Overall (Divisions I - V)</u>

Judges' Commendation(s) may be given to an entry, class, section, special exhibit or other aspect of the show that is of exceptional merit.

Award of Appreciation may be given to thank an exhibitor or group for participation. The award may also be given to non-judged classes.

THE GARDEN CLUB OF MICHIGAN AWARDS

These are **equivalency** awards to be presented only if merited only to exhibitors who are not members of GCA clubs.

FLORAL DESIGN

THE GARDEN CLUB OF MICHIGAN NOVICE FLOWER ARRANGEMENT AWARD

may be given at a GCA Flower Show to an exhibitor who has never won a blue ribbon in the Flower Arrangement Division of a GCA Major or Small Flower Show. It shall be awarded for an arrangement that is a unique and skillful response to the schedule. Novice entries in any competitive Flower Arrangement classes are eligible for this award and will be identified by a colored dot on the entry card. The arrangement must have been created by one person, and must have placed first, second, or third. Members of Garden Club of America clubs are not eligible for this award. [To be presented only if merited and only if the Baylor is not awarded.]

THE GARDEN CLUB OF MICHIGAN FLOWER ARRANGEMENT AWARD

may be given in competitive flower arrangement classes at a GCA Flower Show in recognition of creative work of outstanding beauty using predominantly fresh plant material. The arrangement must have placed first, second, or third. Entries in challenge classes are not eligible for this award. The award is not a substitute for Best in Show and will be given at the discretion of the judges. Members of Garden Club of America clubs are not eligible for this award. [To be presented only if merited and only if the Munger is not awarded.]

HORTICULTURE

THE GARDEN CLUB OF MICHIGAN HORTICULTURE MERIT AWARD is to be presented to an exhibit of exceptional merit in prime show condition. It must have been grown by the exhibitor(s) for six (6) months. The certificate may be given to an individual, joint or club exhibit, but only if there is an exhibit worthy of the honor. Members of Garden Club of America clubs are not eligible for this award. [To be presented only if merited and only if the Beattie Medal is not awarded.]

PHOTOGRAPHY

THE GARDEN CLUB OF MICHIGAN PHOTOGRAPHY CREATIVITY AWARD

may be awarded at a GCA Flower Show in recognition of creative and technical excellence in response to the theme of the schedule. The entry must have placed first, second, or third. Members of Garden Club of America clubs are not eligible for this award. [To be presented only if merited and only if the Photography Creativity Award is not presented.]

NOVICE

THE GARDEN CLUB OF MICHIGAN NOVICE AWARD may be given at a GCA and a GCA Major Flower Show in the Horticulture, Photography and Botanical Arts to an exhibitor who is not a member of a GCA club and who has never won first place or this award in the division entered, of a GCA or a GCA Major Flower Show. It shall be awarded to an individual novice exhibitor or an outstanding exhibit. Novice entries placing first, second, or third are eligible for this award. 
